In consideration of the engagement as a model of the minor, and for other good and valuable consideration of _____ herein acknowledged as received, upon the terms hereinafter stated, I hereby grant to _____ ("Photographer"), his/her legal representatives and assigns, those for whom Photographer is acting, and those acting with his/her authority and permission, the absolute right and permission to take, use, reuse, publish, and republish, as well as to sell photographic portraits or pictures(images) of the minor or in which the minor may be included, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations from time to time, in conjunction with the minor's own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium at his/her studios or elsewhere, and in any and all media now or hereafter known, for art, advertising, trade, or any other purpose whatsoever. I also consent to the use of any published matter in conjunction therewith. I hereby waive any right that I or the minor may have to inspect or approve the finished product or products or the advertising copy or printed matter that may be used in connection therewith or the use to which it may be applied.

I or the minor acknowledge and agree that I have no rights to the images, and all rights to the images belong to the Photographer and/or his/her legal representatives or assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting.

I or the minor further release the Photographer and/or his/her legal representatives or assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the use of the images.

I or the minor acknowledge and agree that I have no further right to additional remuneration or accounting, and that I will make no further claim for any reason to Photographer and/or his/her legal representatives or assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting. I or the minor agree that this release is irrevocable, worldwide and perpetual.

I or the minor hereby release, discharge, and agree to hold harmless and defend Photographer and/or his/her legal representatives or assigns, and all persons acting under his/her permission or authority or those for whom he/she is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or violation of any right of publicity or privacy.

I represent and warrant that I am at least 18 years of age and have every right to contract for the minor in the above regard. I state further that I have read the above authorization, release, and agreement, prior to its execution, and that I am fully familiar with the contents thereof.

This release shall be binding upon the minor and me, and our respective heirs, legal representatives, and assigns.
