Agreement as follows:

For good and valuable consideration of _____, herein acknowledged as received. The undersigned property Owner being the legal owner of and/or have the authority to bind the owner of, or having the right to permit the taking and use of, the images of certain property identified in this Release.

The Property Owner acknowledges and agrees that the images of the property identified in this Release may be supplied by the Photographer or his or her licensees and assigns to any person for any use whatsoever, whole or in part, by any manner of means, without seeking further permission or consideration.

The Property Owner gives permission to create and use the images depicting the Property in any media, for any purpose (excluding defamation and / or pornography) which may include, among others, selling, advertising, promotion, marketing and packaging for any product or service. The Property Owner agrees that the images may be combined with other content, text and graphics and cropped, altered or modified. The Property Owner agrees that all rights to the images belong to the Photographer or his or her licensees and assigns.

The undersigned hereby waives all rights and releases Photographer and his or her licensees and assigns, and shall neither sue nor bring any proceeding against any such parties for, any liability, loss, demands, claims or causes of action, whether now known or unknown, for trademark or any similar matter, or based upon or relating to the use and exploitation of the images of the Property.

The Property Owner further releases the Photographer and/or his/her direct or indirect licensees and assigns, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the use of the images.

The Property Owner acknowledges and agrees that he/she has no further right to additional remuneration or accounting, and that he/she will make no further claim for any reason to the Photographer and/or his/her direct or indirect licensees and assigns. The Property Owner acknowledges and agrees that this Release is binding upon my heirs and assigns. The Property Owner agrees that this Release is irrevocable, worldwide and perpetual.

The Property Owner represents and warrants that he/she is at least 18 years of age and has the full legal capacity and right to execute this Release and grant the rights herein granted with respect to the Property, and to bind all persons claiming an interest in the Property.
